MIDDLETON CITY COUNCIL SPECIAL MEETING JUNE 30, 2017

The special meeting of the Middleton City Council on June 30, 2017 was called to order by Mayor Darin Taylor at 11:00 a.m.

Roll Call: Council Members Carrie Huggins, Rob Kiser and Council President Riccio were all present and Council Member Beverlee Furner was on speaker phone.

Motion to Approve Agenda: Motion by Council President Riccio to approve the agenda, was seconded by Council Member Kiser and carried unanimously.

3) New Business:

Consider approving an amended request from the Middleton Chamber of Commerce for a Special Events permit for 4th of July activities, including a parade on city streets, car show, carnival, vendors, live entertainment, and alcohol vendors all at Middleton Place Park, and a request to waive the \$160.00 permit fee

Mayor Taylor presented the item and answered council's questions, and asked if anyone in the audience would like to speak to this item:

Sergeant Takeuchi of the Middleton Police Department said alcohol consumption is the cause of many accidents and disruptive behavior on the 4th of July. Patrol is increased on that day and evening to maintain public peace.

Council Member Huggins stated that there has been a beer garden before on the 4th of July and that she doesn't remember hearing any bad feedback from. She added that she has a problem punishing everyone for a few that can't behave well.

Council Member Kiser added that the previous beer garden was roped-off and he didn't remember anyone not respecting the barrier.

Council Member Furner asked about the staffing issue for MPD and if a second officer could be added to the night time shift as she understands 4th of July is a busy night for them. Sergeant Takeuchi answered that a swing shift officer will work part of day and night. Council Member Furner asked if there is any availability from Canyon County for assistance, Sergeant Takeuchi responded that Canyon County will be covering their own shifts as well as covering the huge events in Melba on the 4th but will be available for emergencies.

Motion: Motion by Council President Riccio to approve an amended request from the Middleton Chamber of Commerce for a Special Events permit for 4th of July activities, including a parade on city streets, car show, carnival, vendors, live entertainment, and

alcohol vendors all at Middleton Place Park, and a request to waive the \$160.00 permit fee with the conditions that the beer garden be in the south area of the park, it be roped off, have a monitor at the entrance and exit, those drinking are to wear a bracelet, alcohol cannot leave the designated area, and no glass bottles was seconded by Council Member Kiser and carried unanimously.
