## Idaho Power Transmission Line Survey Results

Idaho Power raised the height of its power poles along State Highway 44 east of town from about 50 feet to about 75 feet in order to accommodate a 238 kV line. Idaho Power intends to connect the substation on the northeast corner of SH-44 and Lansing Lane with the substation at the northeast corner of Willis Road and Hartley Lane.

Five routes are being considered by Idaho Power. The City surveyed Middleton residents in the May 2015 FrontPage, and survey results were provided to Idaho Power and are shown below.

### Donated Park Land!

The owner and developer of Falcon Valley Subdivision are donating about seven acres of land to the City for a future park, and constructing about one-half mile of 10-foot wide asphalt trail. The future park and trail will be on the north side of E. 9th Street about one-quarter mile west of Duff Lane. Thank you very much CBH Homes and Trilogy Development!

### Subdivisions

Developers have finished constructing required improvements in the Powder River and The Crossing subdivisions. Powder River Subdivision is located on the south side of Willis Road approximately one-quarter mile east of Cemetery Road. The Crossing Subdivision is located on the south side of Purple Sage Road approximately one-half mile east of Cemetery Road. The City anticipates industrial and more commercial businesses coming to town soon.

### Sign Up for Utility Bill "Auto Pay"

When you sign up for auto-pay, your water, sewer and trash bill is paid directly from your account. The payment will be withdrawn on the 10th of each month. ## Public Hearings – Budget and Maps

Pursuant to Idaho Code 50-1002, the City prepared a proposed budget that City Council is scheduled to consider, and pass an annual appropriations ordinance. The proposed budget is balanced, requests the same property tax dollars as in 2014 (plus tax from new residential construction in 2014), and is substantially (\$3 Million) less than last year's budget.

Pursuant to Idaho Code 67-6509 and 67-6517, the City of Middleton is updating its comprehensive plan and land acquisitions maps.

The City Council is scheduled to consider the proposed budget on August 5, 2015, and maps on August 19, 2015, at 6:30 p.m. at City Hall, 6 N. Dewey Ave, Middleton, Idaho.

The renovated area is now accessible to people with disabilities as required by the Americans with Disabilities Act which required moving a wall and adding a ramp.

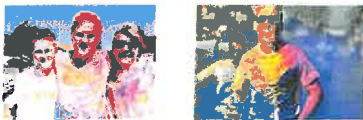
Construction projects are always a huge undertaking, and we are very grateful for the assistance of the Building Official David Wardell, Public Works Foreman James Askew, and the public works staff.
