### Officer Steve Walker Promoted to Sergeant

The Middleton Police Department began in October 2014 with a part-time police chief. Three officers were hired during the winter of 2014, and another officer is scheduled to begin in October 2015. The number of emergency and non-emergency calls increased from four to ten per day on average after Middleton started a police department. Incidents of petit theft, vandalism and other crimes have decreased substantially. Middleton police officer Steve Walker was promoted to Sergeant in August 2015, and he will now oversee operations and other officers when the Chief is not on duty.

### Proper Placement of Garbage Cans

The City has received several complaints about garbage and recycling carts blocking sidewalks on garbage pick-up day, which forces students and residents with disabilities into the streets, which increases the risk of a pedestrian-vehicle collision. In attempt to prevent a tragedy, please place garbage and recycling carts on the road with the wheels backed up to the curb on garbage pick-up day. ## New Withdrawal Date for Utility Bill Automatic Payment Accounts

## Animal Regulations

Middleton schools are back in session, so roads are much busier with cars, pedestrians and pets. There are nine City laws regarding animals and the Middleton Police Department would like remind you about a few of them. Making these city ordinances a high priority will help ensure the health, safety and peace of residents and our four-legged friends.

### City Ordinance 10-3-2: Collar and Tag Requirements

Every dog and cat (canine and feline) shall at all times wear a substantial and durable collar with an identification tag containing the name, address and phone number of the owner.

### City Ordinance 10-3-3: Animals Running at Large

It is against the law for a person to allow an animal which he/she owns, keeps, or harbors to be loose (at large) upon the roads or alleys, or in any park or public place of the City, or upon property belonging to someone else. This provision applies regardless of whether the animal is licensed or not.

### City Ordinance 10-3-6: Disturbing the Peace

It is against the law for a person, unreasonably, to not provide the proper care and control of his/her animal in order to prevent it from disturbing the peace and quiet by barking, whining or making loud or unusual noises, or by running through or across cultivated gardens or lawns belonging to someone else.

Many times an animal can be returned to its owner, rather than the animal shelter, when animal control or law enforcement officers can identify who an animal belongs to.

If you are being disturbed by a barking dog in your area, be neighborly and address the problem with the animal's owner. If the problem is not addressed by the owner and you wish to sign a complaint, please call the Middleton Police Department non-emergency number (208-585-0008).

## FEMA Flood Map Update

FEMA is updating its Flood Insurance Risk Maps for tributaries to the Boise River ... in Middleton, this means Willow Creek and Mill Slough. U.S. Army Corps of Engineers – Walla Walla District is responsible for engineering, Strategic Alliance for Risk Reduction (STARR) is responsible for updates to the regulatory flood maps, and University of Idaho is responsible for risk assessments. Some of the project milestones and deliverables are listed below, and dates are subject to revision as the project progresses.

## Treasure Valley Gang Special Assistant United States Attorney (Gang SAUSA)

Gang-related shootings and other crimes were very high in Canyon County 2004-2006, with over 400 shootings in Nampa and Caldwell alone. In 2007, Treasure Valley cities joined together to fund an United States assistant prosecuting attorney's position dedicated to prosecuting only gang-related crimes. Criminals are prosecuted in federal court and serve time in federal penitentiaries. Real property taxes from residents are no longer paying to prosecute these individuals or keep them in prison, the federal government is paying these costs.

Since February 2007, 317 defendants have been indicted in federal court as part of the Gang SAUSA Project. Of those indicted, 265 have been convicted and sentenced, 13 have pleaded guilty and are awaiting sentencing, 23 are pending arrest or trial, and 16 have resulted in dismissals or acquittals. The conviction rate for defendants indicted by the Gang SAUSA is 95%. The 265 convictions obtained thus far have resulted in a total prison time of 13,846 months (approx. 1,153 years), representing an average prison sentence of 52 months (4.4 years).

Most defendants are also sentenced to at least three years of supervised parole upon completion of their prison terms. 48 defendants are subject to deportation upon completion of their sentences. About 54% of the indictments are for individuals living in Canyon County, about 27% are from Ada County, and 19% from other counties in the area.
