Hello residents,

My State of the City talking points are printed in this issue for your review. Please contact me if you have questions or would like to discuss any of the information presented. The State of the City speech was given on January 8, 2014 to the Middleton Chamber of Commerce and on January 21, 2014 at the Seniors' Luncheon.

City Council and I share the following philosophy about local government and finance:

### **Middleton City Philosophy**

- Fiscally Sound Fiscally Responsible
- Invest in the City
- Listen to the Community
- Growth with a Small Town Feel

Middleton's annual budget is about \$3 Million. The Mayor and City Council use conservative revenue estimates when adopting a budget, and do not go over-budget when approving expenses.

The City has about \$3.8 Million debt: a 2002 sewer bond with \$958,000 balance at 4.5% interest, and the \$2.8 Million bond at 2.75% interest.

#### 2014 State of the City continued

Last year, the City intentionally underestimated revenue as a precaution to ensure the City spent less money than it received. Also, the City sold \$2.8 Million in sewer municipal bonds as approved by City Council in 2009: about \$1.7 Million was used to pay interim financing (US Bank loan) for the wastewater treatment plant, and about \$1.1 Million to pay toward sewer bond debt and to replenish sewer account reserve funds.

When making decisions, especially about budgeting and expenses, Mayor Taylor and City Council make decisions based on what is best for: 1) a majority of residents now (who are paying property taxes and utility bills), 2) a majority of residents in about 10 years when Middleton's population doubles (according to forecasts based on three percent growth rate), and 3) a majority of residents when Middleton is "built out" (about 75,000 people based on regional planning forecasts matched to utility company projections).

Decisions that make sense from all three perspectives are promptly acted on. Otherwise, the best available information is gathered and relied on when making decisions. The City Council is scheduled on February 19, 2014 to consider amending the budget for revenue and expenditure items shown on the back page. Everyone is invited to the meeting to express your ideas, support or concerns. Thank you to everyone for a great 2013!








### **Pavement Management Plan**

One of Middleton's assets is its approximately 43 miles of street network. Maintenance of this street network facilitates the livability and economy of Middleton. The City has developed a pavement management plan to identify and inventory current road conditions, assess and prioritize current and future pavement needs, and develop a 5-year pavement preservation and reconstruction plan.
