Avoid frozen pipes

Leave water running a trickle from inside faucets. If you notice a water-meter lid has slipped or come off contact Water Operator James at 631-8537 to re-secure the lid to avoid freezing water meters and pipes.

Clean leaves, twigs, and debris from gutter stormwater inlets in front of your home to allow free-flow of melting snow and spring rain.

Most sidewalks in town are in City road right-of-ways. Idaho Code 50-317 allows, and City Code 7-6-5(A) requires, landowners/occupants to remove snow and ice from sidewalks on their properties or adjoining sidewalks. Shovel driveways and sidewalks onto lawns and landscaped areas so the soil retains the moisture in early spring before irrigation water is available.

The City of Middleton has established the Middleton Planning and Zoning Commission pursuant to Idaho Code section 67-6504. Commission members are appointed by the mayor with the consent and approval of the City Council. Some of the duties of the planning and zoning commission are as follows:

- A. To recommend and make suggestions to the city council for the adoption of a long range comprehensive plan for the physical development of the city, for the formation of zoning districts, for any changes in zone boundaries and any changes in zoning regulations that may be considered advisable;
- B. To make suggestions concerning the laying out, widening, extending and locating of streets, roads and highways for the relief of traffic;
- C. To make suggestions concerning density of population and development of land within the jurisdiction of the city;
- D. To make suggestions concerning the future growth, development and beautification of the city in respect to its public buildings, streets, parks, grounds and lands consistent with the future growth and development of the city, in order to promote the public health, morals, safety and welfare of the inhabitants of the city;
- E. To cooperate with other and like commissions along the lines and purposes prescribed in Idaho Code title 67, chapter 65.
