# Happy New Year 2015

It has been a year of growth and prosperity for residents in the Middleton Community. Starting in January 2015, the City's Community Assistance Program allows donations to be made with monthly City utility payments:

- 1) to help a resident in need pay a utility bill,
- 2) to help the Middleton Library buy books for children
- 3) to help the Historic Society of Middleton establish the museum downtown.

Congratulations to Middleton High School students for academic, musical and athletic excellence. Girl's cross-country placed 6th in state competition, football placed 3rd, boys soccer placed 2nd, girls soccer placed 3rd, and three members from the marching band were selected out of 5,300 applicants to play in the All Northwest Honor Band.

Mayor and City Council continue taking steps to maintain the small-town feel, pave dirt roads, upgrade water meters, replace deteriorated streets, repair water and sewer lines, and remodel downtown City buildings. The City was awarded more than \$600,000 in grants this year to design and install missing segments of sidewalks to schools, trails to parks, and improve park playground equipment. ## It's Time To Renew Your Business License

All businesses operating in City limits are required to purchase a business license for \$25.00. Forms can be obtained from the City Clerk or found on the city website at [middleton.id.gov](http://middleton.id.gov).

The deadline is January 31, 2015 to avoid a late fee being assessed. If you have questions please contact the City Clerk at 208-585-3133

## New Year's Message (continued)

Home values have risen while new loan interest rates have remained lower. The County Assessor's office reported it raised assessed values up to 25% for Middleton properties, which resulted in higher property taxes in 2014. Meanwhile, the City requested the same real property tax dollars for the City budget as the City did in 2011, plus real property tax for houses and businesses built since 2011, plus \$33,894 to according to state law.

Three subdivisions were approved and houses are being constructed in them: The Pines, Falcon Valley No. 2 and West Highlands No. 4. There were about 160 building permits issued for new residential construction so far this year.

The City selected the following firms/companies to provide professional services from January 1, 2015 – December 31, 2017. The state law requires professionals be hired for projects using the qualification-based selection process. This results in a roster of firms competitively-selected so residents receive professional services by experts in the various disciplines applicable to the City of Middleton.

### **Fire District - 585-6650**

Fire Board Meetings: 2nd Monday at the Fire Station. Owns and manages Middleton Rural Fire District.

Park & Rec Board meetings: 1st Thursday at the park and rec. office on 310 N. Hawthorne. Owns and manages Hawthorne Park, Foote Park and Ed Payne Park.
