State of the City Summary:

In his 2015 State of the City Address, Mayor Taylor described the friendly and giving residents that make Middleton the best place to live. He showcased the following highlights:

- Lowered the budget \$1,000,000
- Lowered monthly water bills
- Returned utility deposits to owner-occupied residences
- Cleaned the clogged 40-year old irrigation and drainage pipe in the east side of town
- Installed "Welcome to Middleton" signs (Eagle Scout projects by Jonah Hall and Sam Bishop)
- Installed signs in parks owned and maintained by the City
- Park benches made by Middleton High School Metal Shop Class
- Built new restrooms and upgraded playground equipment in Middleton Place Park
- Painted shelter at Middleton Place Park (Eagle Scout project by Jacob Dennis)
- Installed new playground equipment in Roadside Park
- Planted 50+ roses in Roadside Park (Eagle Scout project by Andrew Clegg)
- Painted the Civic Center (Eagle Scout project by Kevin Walker)
- Grant awards in 2014-15 will exceed \$1,500,000 for sidewalks, trails, park improvements, and road design
- Started Middleton Police Department

Backflow Inspection:

If you are using City water for irrigation, City code requires that your backflow assembly be inspected annually. Inspections need to be completed by an Idaho licensed backflow inspector and turned in at City Hall by May 30, 2015.

Phosphorus and Fish

Phosphorus in Boise River water causes plants and algae to grow larger and use up oxygen so fish die or there are fewer fish. Also, there are more snags when casting a fishing line or floating the river with your hands or feet in the water.


The federal Clean Water Act authorized the Environmental Protection Agency (EPA) to clean up rivers and lakes around the country. The EPA issued permits to Boise, Notus, Greenleaf, Kuna, and Star limiting phosphorus to 70 micrograms per liter (ug/L).

Boise can discharge five times as much (350-700 ug/L) if it removes more phosphorus from Dixie Slough near Greenleaf. EPA approved the project to achieve 70 micrograms per liter of phosphorus at the confluence of the Boise and Snake rivers.

Canyon County approved a permit to build the Dixie Drain Phosphorus-removal Project, and Middleton appealed because Boise's phosphorus floating past Middleton could: 1) cost residents more to treat phosphorus; 2) limit population growth if Boise's phosphorus discharge uses all the allowable phosphorus load in the River; and 3) degrade river water quality for residents using the River.

Boise has until the year 2022 to meet its phosphorus limits and have the Dixie Drain Project operating.

Boise offered to pay Middleton's costs caused by Boise's higher phosphorus discharge and the Dixie Project and, if Middleton is damaged by June 1, 2027, work jointly to amend EPA permits or other mutually agreed solutions that would remedy Middleton's concerns. Boise and Middleton signed a settlement agreement and Middleton withdrew its appeal.



Three Types of Damage and Injury to Middleton Because Boise will Discharge Above 70 ug/L at its plant(s)

- 1) Livability and quality of life (environmental)
- 2) Increased costs to meet wastewater treatment pollutant discharge concentration limitations
- 3) Limitations on utility expansion/extension, and population growth and development
