RESOLUTION NO. 481-23

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF MIDDLETON, IDAHO ("CITY") FINDING THAT A REFERENDUM PETITION ON THE QUESTION OF WHETHER LIQUOR BY THE DRINK SHOULD BE LICENSED FOR SALE WITHIN THE CORPORATE LIMITS OF CITY HAS BEEN RECEIVED BY THE CITY CLERK; FINDING SAID PETITION SUFFICIENT WITHIN THE MEANING OF IDAHO LAW; ORDERING THAT AN ELECTION BE HELD ON THE REFERENDUM DESCRIBED IN THE PETITION; AND REQUESTING THE ASSISTANCE OF THE COUNTY CLERK IN VERIFYING SIGNATURES ON SAID PETITION AND PROCEEING WITH SAID ELECTION.

WHEREAS, pursuant to Idaho Code Section 23-916, the City is authorized and empowered to license the sale of liquor by the drink within its corporate limits; and

WHEREAS, pursuant to Idaho Code Section 23-917, the residents of City, by referendum, may vote to prohibit the sale of liquor by the drink; and

WHEREAS, an election pursuant to Idaho Code Section 23-917 was conducted, sometime after July 1, 1947 but more than two (2) years prior to the effective date of this resolution, and by majority vote the sale of liquor by the drink within the corporate limits of City was prohibited; and

WHEREAS, pursuant to Idaho Code Sections 23-917 through 23-920, the prohibition on the sale of liquor by the drink within the corporate limits of City may be reversed by another referendum election; and

WHEREAS, in order to place the referendum on the ballot for a vote to permit the sale of liquor by the drink within the corporate limits of City, a petition must be received by the City Clerk that is signed by not less than 20% of the register, qualified electors of City; and

WHEREAS, upon receipt of said petition the Middleton City Council must meet, determine the sufficiency of the petition and, if found to be sufficient, issue an order calling for an election to be held pursuant to Idaho law; and

WHEREAS, a petition has in fact been received by the City Clerk that appears to meet the requirements of Idaho Code Sections 23-917 through 23-920, generally, and specifically with respect to the number of signatures and the qualifications of the signors; and

WHEREAS, the office of the County Clerk for Canyon County, Idaho has resources to assist in verifying the sufficiency of the signatures on the petition; and

WHEREAS, a true and correct copy of the petition, together with all signatures, is attached hereto as Exhibit A and incorporated by this reference.

NOW, THEREFORE, BE IT HEREBY RESOLVED, ORDERED AND DECLARED BY THE MAYOR AND COUNCIL OF THE CITY OF MIDDLETON, IDAHO, AS FOLLOWS:

- 1. The City Council of the City of Middleton, Idaho hereby adopts the legal conclusions and factual findings set forth in the recitals above.
- 2. The City Council of the City of Middleton, Idaho hereby finds that the petition attached as Exhibit A is sufficient within the meaning of Idaho Code Sections 23-917 through 23-920.
- 3. The City Council of the City of Middleton, Idaho hereby orders that the following referendum on the current prohibition of the sale of liquor by the drink within the corporate limits of City be put to a vote, subject to the provisions of Idaho Code Section 34-106 and in accordance with the provisions of title 34, Idaho Code, as follows:

"Sale of liquor by the drink, Yes," []

		"Sale of liquor by the drink, No," []
	4.	The ballot, to be prepared by the County Clerk pursuant to Idaho Code Section 23-918, shall provide that, if sale of liquor by the drink is approved by majority vote, the issuance of licenses for such sale shall commence at any time after the canvassing of votes and certification of election results.
	5.	This resolution, together with the attached petition, shall be delivered to the County Clerk for assistance in the verification of signatures.


