 - C. Consider authorizing two City applications through Valley Regional Transit for: 1) a transit bus shelter at the southwest corner of State Highway 44 and West 4th Ave. South (on Idaho Transportation Department right-of-way), and 2) a transit bus shelter, sidewalk, curb/gutter, park-and-ride lot, and parking lot lighting at the northwest corner of State Highway 44 and West 4th Ave. North.
 - D. Consider approving contract with Grindline skatepark in the amount of \$12,350 for design and construction documents for Phase 1 of the skatepark in Piccadilly Park.
