Weeds

The spring weather brought a lot of rain and unwanted weeds. Property owners are responsible to keep the weeds on their properties cut below 12 inches in height. Weeds are the number one complaint heard from residents at City Hall. We need everyone to do their part to help keep Middleton a beautiful place to live. No building permit required to build or repair a fence in a residential zone

On June 6, 2012 City Council voted to amend city code to no longer require a building permit to construct or repair a fence in a residential zone. Property owners will need to comply with setback requirements, height restrictions and ensure that fences do not block access to water meters or impair vision for drivers as defined by the "sight or clear vision triangle". A copy of the new city ordinance can be picked up at City Hall. The City recommends that property owners contact Dig Line to indentify all underground utilities prior to beginning any building project. Dig line can be reached at 208-342-1585.



Fireworks


Non-aerial common fireworks may be used beginning midnight June 23, and ending midnight July 5. The use of fireworks must also comply with the City noise ordinance Title 8, Chapter 7 which states "sounds caused by fireworks are allowed between the hours of 7:00 A.M. and 12:00 A.M. (midnight) June 23 – July 5. To report violations call Canyon County Sheriff's Office at 454-7531

Understanding the sewer "base rate" on the utility bill

According to Idaho code the City is primarily responsible to provide the following services to residents: water, sewer, trash, streets and police enforcement.

In 2006, it was determined that the City's sewer system would need to be upgraded due to permitting requirements and the growing needs of the community. The existing sewer treatment facility and equipment would be upgraded from a lagoon-based system to a Sequential Batch Reactor (SBR) design. This upgrade was projected to cost \$6.8 million dollars: City funds \$2.1M; \$2.75M sewer bond Middleton residents approved in 2009; and \$2.0M grant through United States Department of Agriculture - Rural Development.

The sewer "base rate" each resident pays on their monthly utility bill is comprised of the City cost to maintain and operate the system, and make bond payments. The City adopted a bond rate incremental increase by resolution 277-09 on May 6, 2009. The current base rate for sewer is \$24.85 per month. The table on the next page shows the incremental rate increases since 2009.



The photograph of the waste water treatment plant (left) shows the current lagoon-based system which is at or near treatment capacity. The new SBR system will service the existing approximately 2,000 connections plus up to 18,000 more providing a long-term sewer plan for Middleton.

How is my utility bill calculated?

Utility bills report charges for several City services: water, sewer, storm water, garbage, and recycling. Water and sewer have two components, "base rate" and "usage rate per 1000 gallons." The usage rate is based on the amount of water the household or business used during the billing cycle. Each residence or business has a water meter and meters are usually read monthly except during December, January, and February when the weather conditions do not permit manual readings. The Public Works Department is changing out old meters (need to be read manually) to meters that can be read with a wand allowing year round meter reading.

The diagram below helps illustrate how the costs are calulated on the utiltiy bill.
