

FEMA Changed Flood Zones Effective June 7, 2019

About 200 residences primarily in Canyon Villa, Middleton Place, Johnson and Park Place subdivisions along Mill Slough were removed from the flood plain effective June 7, 2019. On the same date, about 200 residences primarily in Plum Tree, Willow Creek and Westwood subdivisions were added to the floodplain.



The Federal Emergency Management Agency's (FEMA) December 7, 2018 determination became "effective" (legally binding) on June 7, 2019. Some residents who have been paying for flood insurance coverage will no longer need to, and some who have not in the past will need to arrange for coverage. "No Hunting" in City Parks

The city designated certain publicly-owned lands as city parks: Crane Creek Park, Middleton Place Park, Piccadilly Park, River Park and Roadside Park. Target shooting and hunting are prohibited in city parks, including the nature park along Boise River, named River Park.

State law allows sportsman, i.e., hunters and fishers, access on the river up to the ordinary high water mark. In Middleton, Boise River flows of 2,500-5,999 cubic feet per second are normal flows; 6,000 cubic fee per second is ordinary high-water flow; and 7,000 and above cubic feet per second as flood flow.

The city erected ordinary high-water mark signs in River Park along the river notifying hunters and fishers accessing the river to conduct their sporting activities between the river and the ordinary high-water mark signs. Hunters and fishers further from the river than the ordinary high-water mark signs are in River Park and violating city and state codes.





Local Government Taxing Districts

Several taxing districts provide local government services to Middleton area residents. Fireworks

Non-aerial common fireworks may be used between the hours of seven o'clock (7:00) A.M. and twelve o'clock (12:00) midnight from June 23 to July 5.

Discharging a Firearm

Middleton City Code 10-2-2 allows discharge of firearms in city limits under the following circumstances:

A police officer acting in the course and scope of her or her duties;

A person acting in the lawful defense of that person, other persons or property;

A person discharging a starter pistol or other instrument designed and operated as a noisemaker only;

A person participating in a lawfully-permitted paintball shooting facility or sport shooting range;

A person discharging a firearm for ceremonial purposes, where such person is expressly authorized in writing by the police chief or sheriff or designee and is acting within the time, place and manner specified in such written authorization; and

A person discharging a firearm but not recklessly defined as willful and wanton disregard for the safety or property of others and may cause bodily injury or death to persons or domestic animals or damage to property of others.

Chip Sealing

Each year as regular maintenance, the City chip seals a portion of the City streets. Chip sealing is a cost-effective way to extend the life of the road and save significant tax dollars.

The city is scheduled to chip seal the following roads July 1 through July 3rd.

Hartley Road - SH44 to Willis Rd.

Whiffin Lane - SH44 south to end of asphalt

Willis Road - LDS Church east through the Hartley Ln. intersection

Cemetery Road - SH44 to Willis Rd.

S. Paradise Avenue - SH44 to Boise St.
