

## CEMETERY ROAD PHASE 2 SUMMARY OF PUBLIC OPEN HOUSE: JUNE 28, 2021

The City of Middleton is in the process of building the phase of Cemetery Road that connects Cemetery Road Phase 1 to the Sawtooth Lake Drive Crossing. Community Members were invited to review design elements and give comments about the project.

A public open house was held at the Middleton City Hall on June 28, 2021. Three members of the public and three members of city hall staff attended, and no one gave written comments.

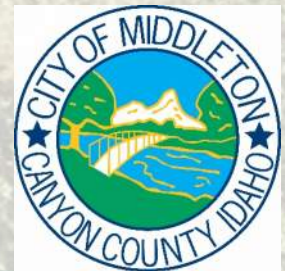

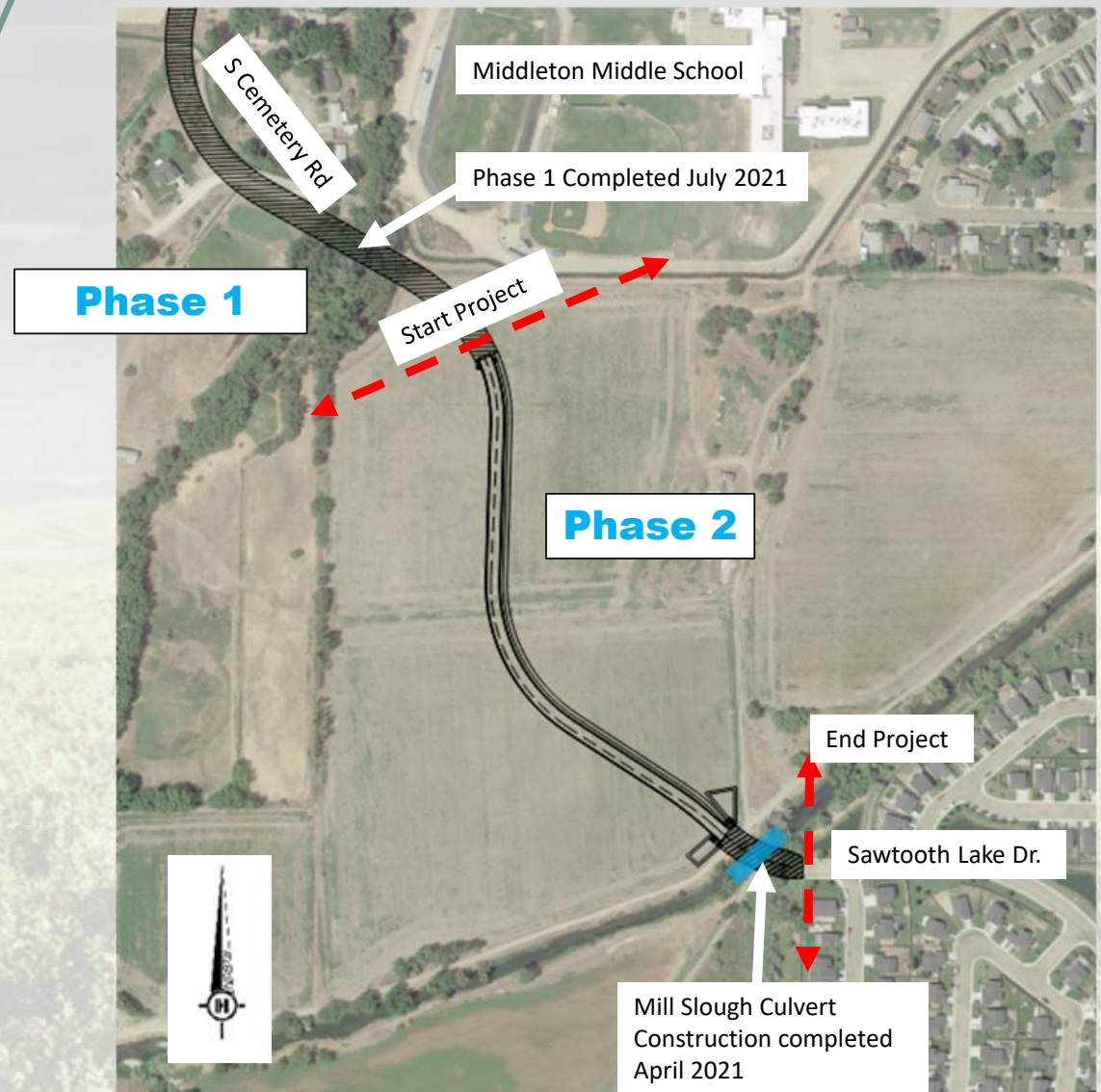

# Project Overview

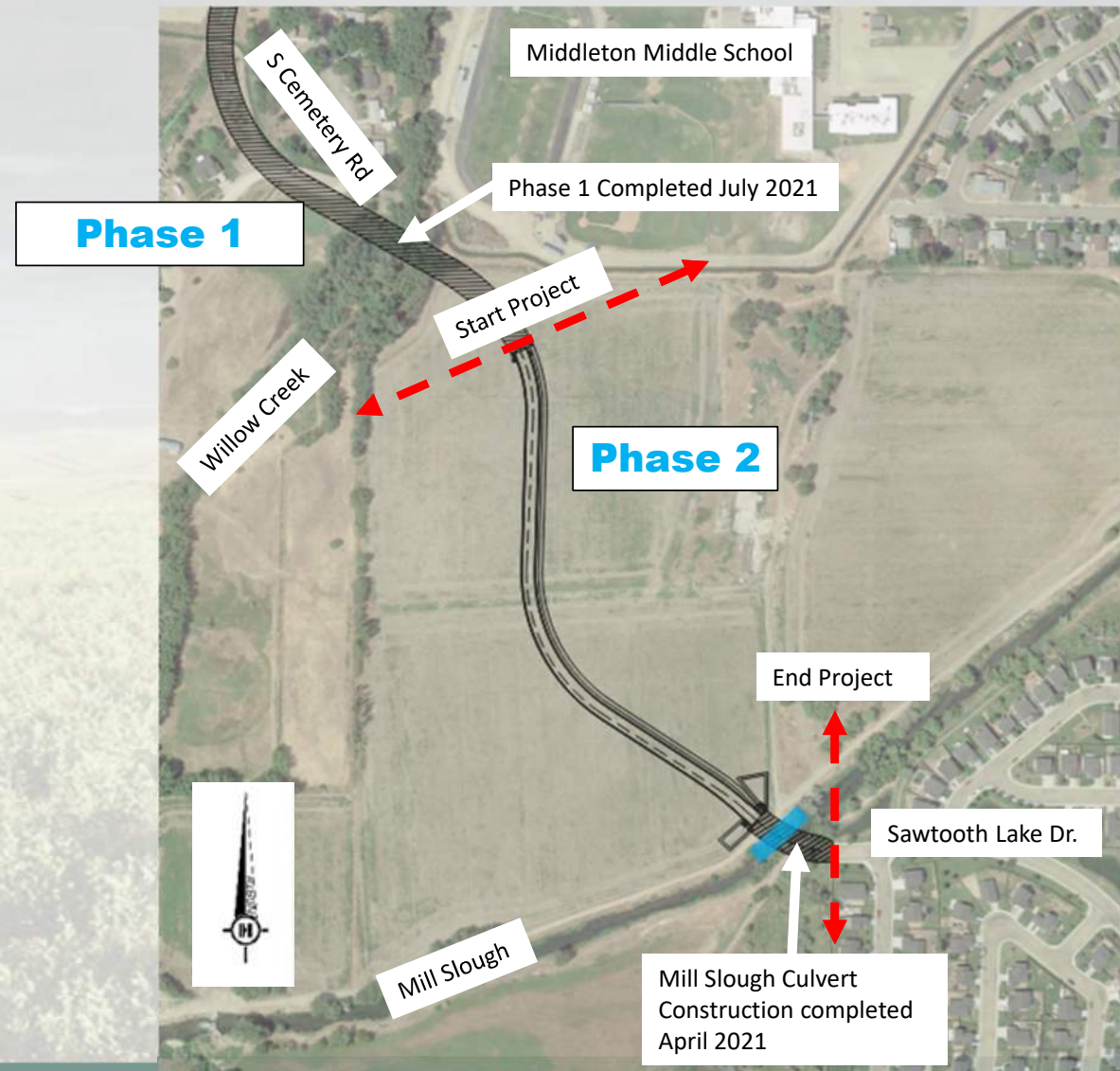
- Connect Phase 1 to Sawtooth Lake Drive
- 10' multi-use path on east side of road and tie into and end Phase 1 sidewalk on west side of the road
- 0.32 mile roadway
- Pedestrian access to Middleton Middle School from Sawtooth Lake Drive

- Federal Grant is funding 93% of Phase 2 construction
- Limits: 350 ft south of Willow Creek to Sawtooth Lake Drive
- Two storm drainage ponds NW of Mill Slough Culvert

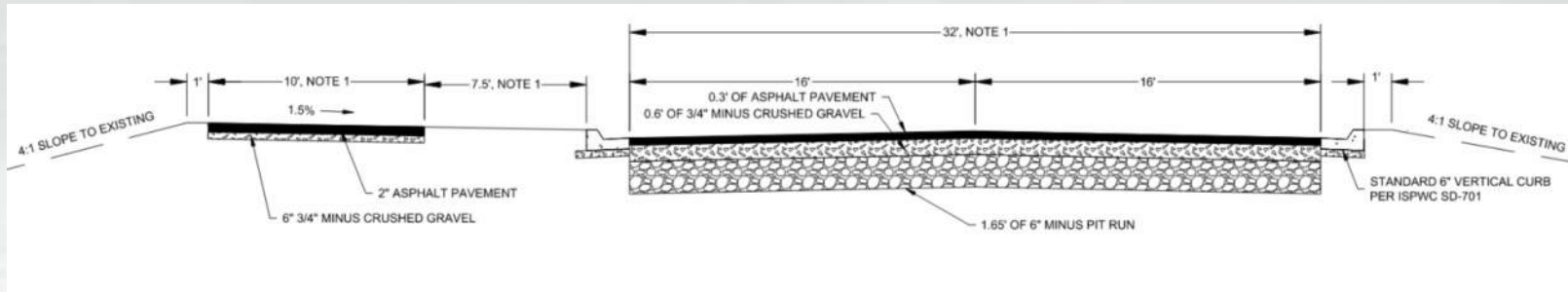

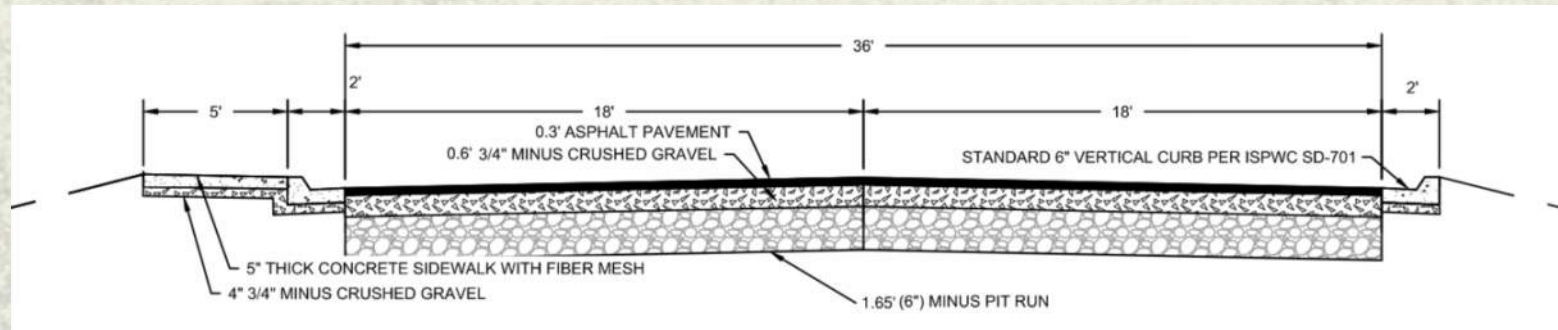


# Roadway Typical Sections

Typical Section



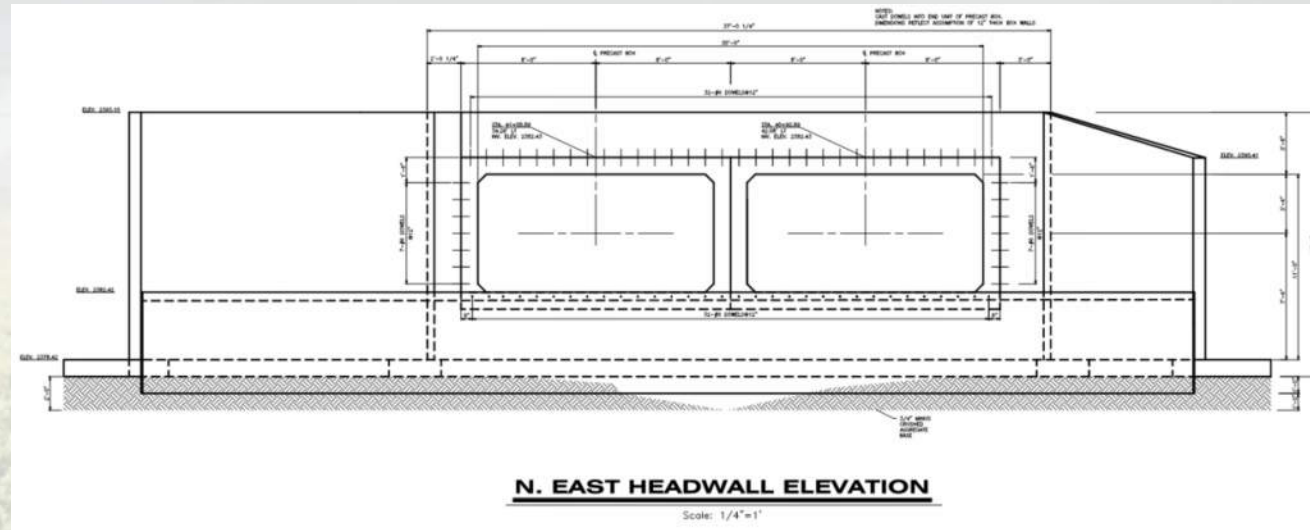
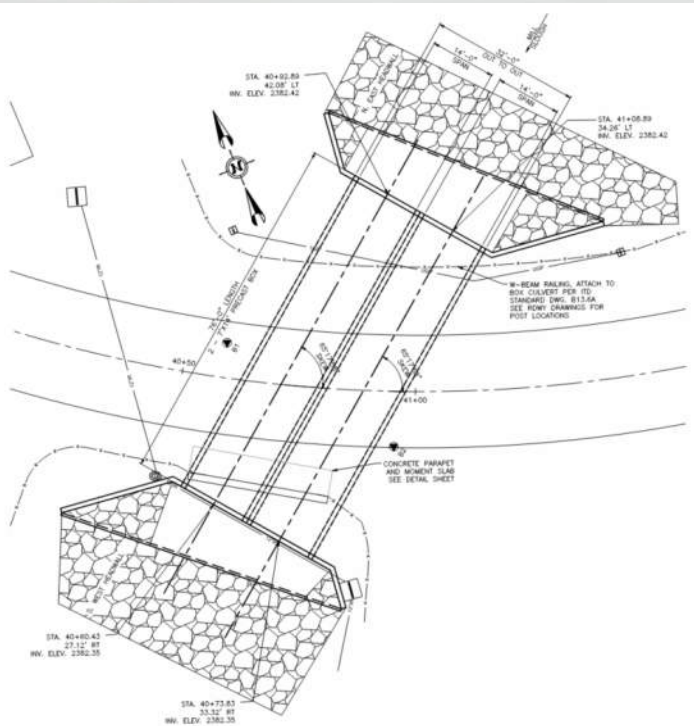
Mill Slough
